विषय:- अखिल भारतीय आयुर्विज्ञान संस्थान, नई दिल्ली में जूनियर मेडिकल रिकॉर्ड ऑफिसर के पद पर पदोन्नति को रद्द/वापस करने के संदर्भ में।

Subject:- Promotion to the post of Jr. Medical Record Officer at the AIIMS, New Delhi-
cancellation thereof.

Vide this office Order of even number dated 13.07.2024 on the subject cited above, Shri Ajay Kumar Sharma, MRT was offered promotion to the post of Junior Medical Record Officer against the post meant for NCI Jhajjar from the date he assumes the charge to the post within 10 days from the date of issue of office order failing which it would be presumed that he has denied his promotion.

Further, vide office order dated 10.08.2024 Shri Ajay Kumar Sharma, MRT was directed to join on promotional post at NCI, Jhajjar within 07 days, with the conditions that failure to join the post will resultant in cancellation of his promotion order. However, Shri Ajay Kumar Sharma, MRT has failed to join the post of Jr. MRO in NCI Jhajjar within stipulated time and till date.

Accordingly, in terms of the order of even no dated 13.07.2024 and office order dated 10.08.2024, the promotion of Shri Ajay Kumar Sharma, to the post of Junior Medical Record Officer Stands cancelled.

Further as per DOPT guidelines he will not be considered for promotion for a period of one year or till a next vacancy arises, whichever is later.
