6. An undertaking that the bidder has arrangements with the OEM/OEM's A uthorized National distributor to provide per copy contract and will provide per copy contract from Day one should be given in the bid as additional do cument. The per copy contract/services will have to be given by the bidder

himself and not by other agencies. Undertaking in this regard has to be giv en.

7. The operating System has to be Factory Preloaded. An undertaking in thi s regard is to be uploaded by the bidder failing which the bid will be rejecte d.

8. The Bidder should give declaration that he will install the material Free o f charge. Also, an undertaking should be given that bidder will install these items as and when desired by the User and will not insist on installation in one go. All the software provided will be installed by the bidder as and whe n desired by the user department. The bidder should not insist on installati on in one go and must submit a declaration in this regard.

9. No deviations in the specifications of any of the above items will be acce pted. The Bidder should clearly declare in the BOQ Compliance that all ite ms meet all the specifications as required. Detailed tabulated deviation spe cifications should be given clearly specifying if each specification is met rat her than blanket statement like – "all specifications met".

10. In the overall total Bill of material mentioned in the BOQ Bid, the amou nt quoted should have 20% or more Make in India (MII)/Local content.
